

END-USE/END-USER STATEMENT

In consideration for its purchases of products from Cornell Dubilier, Purchaser certifies that:

- 1) I (We) will determine any export and reexport license requirements to export the products from the United States and, as applicable, to reexport the products outside the United States, obtain any export or reexport license or other official authorization, and carry out any customs formalities for the export or reexport of the commodity, using a duly authorized U.S. agent. I (We) further agree to ensure that its authorized agent will provide Cornell Dubilier with a copy of the customs export formalities (e.g., relevant sections of the EEI) for its files upon request.
- 2) I (We) will abide by all applicable U.S. export control and economic sanctions laws and regulations for any products purchased from Cornell Dubilier Electronics.
- 3) I (We) am/are not a restricted, blocked, denied, or prohibited party on any list maintained by the U.S. Government, including but not limited to the Entity List, Table of Denial Orders, or the Specially Designated Nationals and Blocked Persons List ("SDNs"), or persons owned 50% or more, directly or indirectly, by one or more SDNs (collectively the "Restricted Parties Lists").
- 4) I (We) will not directly or indirectly export, reexport, or transfer (in-country) any Items to anyone on the Restricted Parties Lists without authorization from the U.S. Government.
- 5) I (We) will not directly or indirectly export, reexport, or transfer (in-country) any Items to Belarus, Cuba, Iran, Libya, North Korea, Russia, the Crimea, Donetsk, and Luhansk regions of Ukraine, Sudan, or Syria.
- 6) I (We) am/are not a military end-user or military intelligence end-user in Belarus, Cambodia, China, Myanmar/Burma, Nicaragua, Russia, or Venezuela.
- 7) I (We) will not export, re-export, or transfer the Items to or within Belarus, Cambodia, China, Myanmar/Burma, Nicaragua, Russia, or Venezuela for a military end-use or military-intelligence end-use.
- 8) I (We) further certify that the product(s) will not be used, directly or indirectly, or provided to customers involved in nuclear explosive activities, unsafeguarded nuclear activities, or in the research on or design, development, construction, production, stockpiling, testing, operation, use, or maintenance of nuclear explosive devices or nuclear propulsion projects, chemical or biological weapons or the related parts, components or subsystems of any of the foregoing.
- 9) I (We) further certify that the following is a complete listing of the parties to this transaction:
